## Frozen Semen Contract

I hereby agree on this \_\_\_\_\_ day of \_\_\_\_\_ to breed the mare \_\_\_\_\_ registration #, \_\_\_\_\_ to **Rowdy Yankee** Registration # 3338478 using frozen semen for the 2012 breeding season.

1. Mare owner agrees to pay a non refundable booking fee of \$500. The balance \$2000 breeding fee and the \$250 forzen semen fee will be due before shipping of the semen. These fee must be paid in full before semen will be released. This fee includes 3 doses of semen (8 straws) during the mares first heat cycle. Each breeding dose of semen (8 straws) requested thereafter will require an additional fee of \$250/dose, to cover freezing costs. All charges in relation to the shipment of the semen and returning of the shipping container are to be paid by Mare Owner.
2. A copy, both sides, of the registration papers of your mare must accompany this contract. The recorded owner on the registration certificate will be the owner recorded on the Stallion Breeding Report.
3. This Contract contains a "Live Foal Guarantee". A live foal is described as a new born foal which stands and nurses without any assistance. If a foal is born dead, or the mare absorbs/aborts a predetermined pregnancy there are return privileges, only if the Stallion Manager is notified within Thirty (30) days and received a statement confirming the miscarriage. A "Live Foal Guarantee" will apply only to those mares that are certified in foal by a licensed, attending Veterinarian. Confirmation of such pregnancy in the form of documented ultrasound pictures or letter from the attending veterinarian must be received by September 1<sup>st</sup> of the breeding year or the mare will not be included in the Stallion Breeding Report.
4. If the mare absorbs or aborts a pregnancy after having been pregnancy check in foal, or if the mare fails to conceived during normal breeding season, the Stallion Breeding Manager agrees to breed the same mares again during the following breeding season. There is a charge of \$350.00 for re-breed fee service. Mare will have to pay \$250/dose for any additional dose they may need to breed there mare. If mare owner did not use all 3 doses on the first year of breeding (paragraph one) they can use them with no additional cost. A substitute mare, accepted by the Stallion Manager, may be used ONLY if the original mare is deceased or deemed unfit for breeding by an accredited veterinarian.
5. A Breeding Certificate will be issued for the foal conceived as a result of the breeding. The Breeder's Certificate will be issued only after all expenses have been paid in full.

6. Neither Sunny Pines Farm, Inc. nor any of its member or employees shall be liable for any damages to the semen or as a result of the mare failing to settle. Sunny Pines Farm, Inc. sole liability under this contract is in the even the Stallion should die or become unfit for breeding purposes this contract shall terminate and any money paid on the stallion fee, except the non-refundable booking fee, shall be refunded to the Mare Owner, at the exception of this mare already been expose the same breeding season.
7. When sing by both parties this document will become a legally enforceable contract, binding upon both parties. The parties acknowledge that this agreement shall be entirely governed by, construed and enforced under the law of North Carolina. In the event that there is any dispute, all disputes of every kind between the parties to this agreement shall only be submitted to arbitration and any award made by the arbitrators shall be considered final and binding.
